**Saddleback Ski and Ride School Release of Liability Agreement**

I fully understand that skiing and snowboarding are hazardous sports and that these snow sports, and the use of ski or snowboard equipment, involve a risk of injury to any and all parts of a student’s body. I further understand that the use of any ski lift and the performance of any exercise and/or maneuvers as recommended by the Ski and Ride School staff also involves the same risk of injury. I understand that there are times in a lesson that a student may need to ride a lift alone or with someone other than the instructor. (Please initial\_\_\_\_\_)

I also understand that ski area conditions vary constantly because of weather changes and skier use, and that the ski area may contain ice, variations of terrain, moguls, forest growths, rocks, debris, lift towers, other skiers and snowboarders, snowmaking and grooming equipment and other obstacles and hazards which may be marked or unmarked. I understand and agree that it is my responsibility to be aware of and obey any and all markings and posted signs.

Accordingly in consideration of your agreement to provide me with ski or snowboard instruction, **I (for myself and my child, if the student is a minor), hereby agree to Release, Hold Harmless and Indemnify, Saddleback Inc. & Saddleback Land & Timber Corp. hereinafter “SADDLEBACK”**, its owners, affiliates, subsidiaries, employees and agents and all of their officers and directors (the Releasees) from any and all responsibility or liability for injury or property damage resulting directly or indirectly from any alleged negligence of the Releasees relating to skiing or snowboarding or the use of ski or snowboard equipment and/or this student’s participation in the Saddleback Ski and Ride School class or private lesson. I further expressly agree not to sue or make any claim against the Releasees on any matter referred to above. (Please initial\_\_\_\_\_)

This Agreement is intended to comply with the laws of the State of Maine and only to the extent allowed by law. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.

I (for myself and my child, if the student is a minor), agree that all disputes arising under this contract or my use of any and all facilities at SADDLEBACK, shall be litigated in the State or Federal courts in the State of Maine and governed by its laws and procedures.

I (for myself and my child, if the student is a minor), further agree that this contract is binding upon myself, my heirs and assigns. To the extent that I am signing this document on behalf of any minor, I represent and guarantee that I have full authority to do so realizing the full binding effect of this contract on them as well as on myself, and I further agree to indemnify and hold harmless the Releasees for any claims of negligence brought on behalf of the minor relating to any damages allegedly sustained by the minor while he/she was practicing for or participating in the Event.

I also agree, that in the event that anyone makes any claim against the Releasees as a result of any of my activities on their premises or the use of their facilities, that I will indemnify and hold harmless the Releasees from such claims including any and all court costs and attorney fees.

I have carefully read this agreement and the release of liability and fully understand its contents. I am aware that this is a release of liability including negligence and a contract between myself and the Saddleback Ski and Ride School I sign it voluntarily with full knowledge of its significance.

I grant permission to Saddleback to use my photo/video on its World Wide Web site, in official printed publications, and other media forms and I acknowledge SADDLEBACK’s right to crop or treat the photo/video at its discretion. I also understand that once my image is posted on SADDLEBACK’s website, the image can be downloaded by any computer user. Therefore I agree to indemnify and hold harmless from claim SADDLEBACK, its owners, employees and agents. Date \_\_\_\_\_
